**Sub: Gazette Notification amending PPV & FR Rules 2003 - Reg**

Ref: Gazette Notification No.G.S.R. 494(E) dated 15-06-2015 of Ministry of  
Agriculture (Department of Agriculture & Cooperation)

In the Gazette notification referred above, the Central Government has issued the Protection of Plant Varieties and Farmers' Rights (Amendment) Rules, 2015.

Vide Rule (2) of the above amended rules, Rule 8(1) of the Protection of Plant Varieties and Farmers' Rights Rules 2003 has been amended and amount of fees payable in respect of registration of plant varieties and grant of any right under the Act or any application or any document to be filed under the Act or Rules have been revised and the new rates have been specified in the Second Schedule.

Neither the draft notification nor the proposed rates to be revised were put on the PPV & FR website, calling for comments/suggestions/objections from the public. By not putting the draft notification on the website, the concerned stakeholders were deprived of an opportunity to put forth their suggestions/comments or even raise objections, which could have been considered by the Central Government before finalizing and issuing the Gazette Notification. The seed industry is, particularly, concerned with the revision and fixing of abnormally high rates in the Second Schedule. Fee has been revised steeply as high as 4 to 10 times of the existing fee. To quote a few instances :

- Registration fee for commercial varieties (S.No.5,7 & 8 of Second Schedule) raised from Rs.10,000/- to Rs.50,000/-
- DUS Test Fee (S.No.1 of Second Schedule) raised the maximum limit from Rs.50,000/- to Rs.2,00,000/- and from Rs.2,00,000/- to Rs.8,00,000/-
- Renewal fee for commercial varieties (S.No.9 of Second Schedule) raised from Rs.10,000/- to Rs.80,000/- per year (it means against the existing fee of Rs.90,000/-, the revised fee works out to Rs.7.20 lakhs towards renewal of the registration of plant varieties)

- Earlier there was no fee for inspection of entries or for obtaining certified copies under section 84 by filing PV-33. Now, the fee specified (S.No.32 and 33 of Second Schedule) is Rs.1,000/- per entry and Rs.500/- per page). This is highly unreasonable and illogical, when compared to the nominal cost/fee charged to the applicant for providing the documents under provisions of Right to Information Act, 2005. The RTI Act 2005 prescribes 30 days for providing the information and documents. Despite representations, timeline is not yet prescribed by the Authority for providing the documents to the applicants and yet such huge prohibitive fee is specified.
- Huge fee of Rs.20,000/- (S.No. 24 of Second Schedule) is prescribed for alteration of denomination.
- Fee is even specified for filing application of surrender of Certificate of Registration (S.No.15 of Second Schedule)


The above are few instances to highlight as to how the fee is very high and prohibitive. **Detailed statement comparing existing and revised fee with comments is enclosed.**

The fee is so huge and prohibitive that small seed companies or even individual breeders can not afford the same and even big companies may also be discouraged from filing of applications for registration of varieties due to huge cost involved. We state that the Object of the PPV&FR Act is to encourage the development of **New Varieties**. New Varieties can be developed by any person including Large Multi National Companies or Small Companies or even for that matter an individual breeder. The unreasonable and irrational increase in the fee would act as an impediment for development of New Varieties and would defeat the very objective of the Act.

We request to kindly withdraw the notification and revise the fee after discussions with the stakeholders and meanwhile continue the existing fee structure till a final decision is taken on the revision.
